

FEASTA DATA PROTECTION - REGISTER OF SYSTEMS

1. Databases

- (a) *Member database.* Feasta holds databases of members' details solely for the purpose of membership records. The details we collect and store are the following: contact names, physical and email addresses, phone number(s), payment amount and method and your agreement to sign up to Feasta's [Statement of Ethos and Values](#). We do not collect or store sensitive information such as credit card or bank account details, race, gender, sexual orientation, political affiliation and religion. The information we collect will not be shared with other bodies unless it is necessary to meet our legal and regulatory obligations. We use Paypal and bank transfer protocols to process payments.
- (b) *Mailing lists* Feasta has been using the services of Mailchimp to handle its mailouts to our newlist and our members. We use this information to facilitate our activities such as meetings, events, training, and other Feasta-related correspondence and to keep members of the Feasta community up to date on news and events. This data remains active until you request for it to be removed from our list. If you would like to be removed from this list please email: info@feasta.org. Feasta will ensure that any mailing list software it uses has a suitable data protection policy in place and that subscribers are made aware of this. Our mailing list contains only email addresses and, optionally, user names. We keep a password-protected backup of our mailing lists.
