8. North American Report (see notes attached)

Mike outlined a window of opportunity for federal legislation on capital dividends (estimate of 6 to 9 months). Campaign to be conducted through website "Dividends for America (domain name held by Mike Sandler). Mike is redesigning the website to use it for the campaign.

1. Webinar on universal basic incomes proposed by Gwen Hallsmith outlined. Interesting to note piece in today's NY Times on the Child allowance in the US stimulus bill, highlighting social justice (women of color) benefits. This is seen as a first step in universal basic income.

Use of the name Feasta is still being explored. It is not being used on all the North American group materials. The group is still called Feasta North America but the current campaign title of "Dividends for America" is being used on our materials.

Brent noted that the Feasta name is confusing when reaching out to US politicians on climate issues. But the Feasta name is being used name in other contexts – on case by case basis.
